

## Matrix Service Inc. Awarded Large EPC Tank Construction Projects From North Dakota Pipeline Company

TULSA, Okla., Nov. 6, 2014 (GLOBE NEWSWIRE) -- Matrix Service Company (Nasdaq:MTRX) announced today that its subsidiary, Matrix Service, Inc., has been awarded an engineering, procurement and construction (EPC) contract by North Dakota Pipeline Company, LLC (NDPC), a subsidiary of Enbridge Energy Partners, L.P. (Enbridge). NDPC is expanding four existing crude terminal locations in North Dakota and Minnesota to support the proposed Sandpiper Pipeline Project (SPP). If approved, the 610-mile SPP will deliver Bakken light crude oil to U.S. and eastern Canadian refineries.

The contract award includes seven aboveground storage tanks with capacity in excess of one million barrels. Work will occur at terminal locations along the Sandpiper Pipeline including Beaver Lodge, Stanley and Berthold, N.D., as well as Clearbrook, Minn. This award further enhances Matrix Service's already strong alliance with Enbridge and NDPC.

Said John Hewitt, CEO of Matrix Service Company, "This expanded alliance award with NDPC further strengthens our long-term commitment and relationship with Enbridge while continuing to support the build out of North America's energy infrastructure."
